

Central Square School District is operating the 2025-2026 school year under the CEP school lunch program. All students are eligible for 1 reimbursable breakfast and 1 reimbursable lunch per day at NO CHARGE. Lunches include 1 entree item, 1 fruit, 1 vegetable and 1 milk. A la Carte items such as milk, ice cream and snacks are still available and must be paid for at the time of purchase or with money on the student's account.

Families are asked to complete the 2025-2026 Household Income Eligibility form unless they receive a Direct Certification letter from our office. Federal funding for district wide programs rely on this information. Applications are available on our website.
