SUMMARY & BACKGROUND

On March 11, 2021, the President signed into law the American Rescue Plan Act of 2021 (ARP). ARP makes available \$122.8 billion nationally in a third round of Elementary and Secondary School Emergency Relief (ESSER) funds. New York State has been allocated nearly \$9 billion under the ARP Act's Elementary and Secondary School Emergency Relief (ESSER) Fund. The ARP Act requires that a minimum of \$8.09 billion (90 percent) be allocated to LEAs, including charter schools and Special Act School Districts that are LEAs. Pursuant to the terms of the ARP Act, LEA allocations have been calculated using the relative shares of grants awarded under Title I, Part A of the ESEA for the most recent federal fiscal year (2020). Each eligible LEA's ARP-ESSER allocation may be found HERE.

Under section 2001(d)(2) of ARP Act of 2021, each State Educational Agency (SEA) must make ARP-ESSER allocations to LEAs in an expedited and timely manner and, to the extent practicable, not later than 60 days after the SEA receives its ARP-ESSER funds. The first portion of ARP-ESSER Funds was awarded to states on March 24, 2021, and 60 days from that day is May 24, 2021. Upon receipt of such notice, LEAs were able to begin obligating their allocation of 90% base ARP-ESSER funds.

ARP-ESSER Application – Part 2: The second step will be the submission of a full application and budget by the LEA. NYSED will issue a Grant Award Notice (GAN) to the LEA after the LEA's application is fully reviewed and approved by NYSED. Part 2 will address several of the plan-related assurances an LEA must provide in Part 1 of the application process.

The ARP Act requires LEAs to reserve at least 20% of their 90% ARP-ESSER allocation to address learning loss through the implementation of evidence-based interventions, such as summer learning or summer enrichment, extended day, comprehensive afterschool programs, or extended school year programs, and ensure that such interventions respond to students' academic, social, and emotional needs and address the disproportionate impact of the coronavirus on economically disadvantaged students, children with disabilities, English learners, racial and ethnic minorities, migrant students, students experiencing homelessness, and children and youth in foster care. Throughout the pandemic we have received 1000's of phone calls and emails from parents expressing their feedback and concerns regarding the district's long term plan to address the negative impact the pandemic has had on their children. There was clearly a pattern of concerns stemming from the learning loss resulting from distance learning to the mental health issues students experienced as they were isolated from their peers. New York State has provided us with Federal funding to address and accommodate those very concerns. We feel that the positions and programs being created will not only close the learning gap but will also address social-emotional needs, while also re-engaging our students in their school community.

Here is a Google form that allows parents/guardians and community members to ask questions regarding our plan. If you wish to receive a response to your question you must leave your name and email that we will respond to. The District welcomed any comments. We are extremely grateful for the support that parents/guardians provided their children throughout the pandemic. Our goal moving forward is to utilize Federal funds to make sure that all students are on the right path to succeed.

All of this was considered as planning meetings took place to prepare the District's final funding proposal. The proposal is available on the website as required. The google form is still there for any comments. The Board of Education held a presentation on this funding plan at the June 21, 2021 meeting. Our meetings are also open to the public and board meetings agenda items are available on the website. All meetings are posted as required by the open meetings regulations.

Safely returning students to in-person instruction

As students have started returning, we are finding that support staff are needed to implement the public health emergency regulations. Many areas are impacted. The school nurse needs additional support. The funding will allow the district to add an additional assistant in each of our 4 elementary nurse's office. This gives the nurse's the ability to contact trace for the county as well as provide COVID testing to students. These positions will assist the nurse in facilitating COVID protocols, including contact tracing, health screenings, temperature checks, isolation room monitoring, etc. Monitors for entrance procedures as well as cleaning protocols in the cafeterias are another area in need of support.

There are currently 4 Safety Patrol Officers (SPO's) for 6 school buildings. We are adding 2 more to keep security in all buildings during the school days.

This funding will allow the District to safely return all students to classrooms by modifying and/or reconfiguring spaces and areas. The appropriate furniture is necessary to achieve this goal. Many classrooms have moved away from the basic classroom setting of an individual desk and chair for each student. This is actually what is needed again to keep appropriate distancing between students. This is to replace classroom furniture districtwide. There are 4 elementary schools, a middle school and a high school. Student population of approximately 3500. The District is looking at "SmartLink" education furniture. It is a collection of tables, student desks, and seating. These are a style of classroom furnishings that offer the ability to seat students separately for individual, focused study. Also, meets our distancing requirements. The good news is that these pieces can also be placed together for collaboration. At some point in the future, we would want to have the ability to have students collaborate again in small group, etc. This type of furniture allows the District to have options moving past the COVID-19 regulations. This type of furniture may also be able to be useful in our special needs classrooms, depending on student IEP's. There is also a small amount for general office furniture to accomidate the new staff.

The District is also including the purchase of addition 360 Clorox cleaning machines to enhance cleaning and disinfecting protocals. One machine for each of our 6 school buildings.

Per the District's Comprehensive Improvement Plan (DCIP), we are using attendance, courses passed, and number of students who access metal health services to monitor and measure the success of this plan. The basic goals of this mirror those of the ARP ESSER initiatives.

Elementary schools are using Benchmark data, DIBELS 8, to determine what level of support the students need to close the achievement gap. We progress monitor the students bi-weekly to gauge the level of success in those interventions. Groups are flexible based on students response to the interventions. If students continue to struggle they follow the RTI process and are referred to the SBIT team.

At our middle school, students are being progress monitored using STAR Reading and Math as well as DIBELS 8. There are also common formative assessments administered to gauge acquisition of the skills in content areas. This data drives small group instruction, after school programming and AIS placement.

At our high school, students are progress monitored using STAR Reading. As a result of an ELA and Math audit, common assessments are being developled. Results of the STAR assessment and subject area performance determine AIS placement for targeted support.

Offering evidence-based summer, afterschool, and other extended learning and enrichment programs

The District plans to add an additional .8 FTE music teacher to enrich the music program and increase student engagement at the Middle School. There will be a new district wide extended day program to address academic, mental health and mentoring needs. The district has already implemented additional summer school support at the elementary and secondary level to address learning loss and credit recovery so students will be able to graduate on time as many were impacted during the pandemic.

Addressing the impacts of the COVID-19 pandemic on students, including the impacts of interrupted instruction and learning loss and the impacts on low-income students, children with disabilities, English language learners, and students experiencing homelessness. The Transportation Department has developed the appropriate protocols and procedures to meet the public health requirements. This brings additional routes, due to social distancing needs. We also have experienced an increase in homeless students. The funding will provide some support with additional transportation vehicles and a dispatcher.

Supporting early childhood education

Due to the disruption of the pandemic on families, we will be adding one FTE UPK teacher outside of the UPK grant which will eliminate our waiting pool allowing all eligible students to participate. This will provide students access to mental health services that otherwise would not have been available until the child entered kindergarten.

For extended day programming, we ensure that students who are currently homeless or in Foster care are included in those offerings at all levels. We currently don't have any migrant students. Our ELL staff has changed to accommodate the needs of our ELL students. We have worked with our Mid-State R-BERN to assist with programming. A change in our Elementary Master Schedule has allowed all students with disabilities and all students to access research based ELA strategies and extra intervention periods. At the middle school additional diagnostic assessments have been implemented to guage the growth of our students with disabilities. We have also engaged a consultant to strengthen the instruction in our self-contained classrooms.

We will create three FTE primary positions, one kindergarten, and two first grade classrooms in order to reduce class size which supports the development of foundational literacy and numeracy skills.
