IMPROVED FOCUS

Superintendent's Message

Dear Parents/Guardians:

The Central Square Central School District is very special and unique for several reasons. Our staff is highly-qualified and extremely dedicated to empowering all students to excel as citizens in a changing world. This is not only our mission statement, but it is our daily focus and responsibility to all of our students and their families. Even though our school district spans over 200 square miles, making us one of the geographically largest school districts in New York State, we still have a strong sense of community in each of our six schools. Our motto is, "As One We Rise, Together We Soar," which can be witnessed in classrooms, in athletic arenas, at music/band competitions and recitals, and throughout all of the clubs and activities that our students participate in.

At Central Square, we do not believe in jamming square pegs into circle holes, and that is why we provide our students with multiple career pathways. We have some students who graduate and enroll in colleges and universities, while other students go directly into the workforce, and a growing number of students take the military pathway, whether that be an ROTC program, enlist directly into the military, or enroll in a prestigious military academy. Our goal is to provide each student with an opportunity to take specific courses and engage in a variety of after-school activities that give them the skillsets that they need to be successful for their preferred career pathway. We send more students to CTE programs at CiTi BOCES than any other district, especially with all of the available jobs in the skills trade. Our college/university pathway is very strong and students can receive their two-year associate degree at the same time they are fulfilling their requirements to graduate from Paul V. Moore High School. We have one of the strongest internship/job shadowing programs compared to the majority of high schools in New York State. We provide our students with hands-on experience in their preferred

field and that experience is invaluable, as it either reinforces their future career exploration in that particular field or it gives them the opportunity to recognize that specific career field is not for them instead of spending hundreds of thousands of dollars to pursue that specific career field.

Our athletic program and fine arts program continue to receive numerous accolades and recognition, and we have a significant number of students who go on to play collegiate athletics and attend college on music/band scholarships. Volunteerism plays a huge role in our district, which is illustrated by the numerous events run by the PTO or by local businesses where Central Square high school students are putting in many volunteer hours.

The arrival of Micron, in basically our district's backyard, has the potential to greatly increase our enrollment numbers within the next five to seven years. To prepare for the increased demand of thousands of jobs, we are not only looking at our own Technology Department, but also working with CiTi BOCES to make sure that the courses and CTE programs available to our students align with what will be expected from successful candidates to be employed either at Micron or one of the many industries that will also be moving into our area as a result of Micron's arrival. Transportation

Please take a moment to read the bus regulations and review them with your child. For public safety, the Central Square School District buses are equipped with video cameras.

- Observe the same conduct as in the classroom.
- Be courteous; do not use profane language.
- The bus driver is authorized to assign seats and require the use of seat belts.
- Always cross at least 10 feet in front of the bus.
- Keep head, hands and feet inside the bus.
- Cooperate with the driver.
- Do not be destructive.
- Keep the bus clean.
- Stay in your seat.
- All students must be ready and on time for the arrival of their bus in the morning.
- No secondary students will be allowed to ride elementary buses to school.
- If students miss their morning bus, they or their parents will be responsible for transportation to the middle school or high school.
- When a student loses riding privileges, it is the responsibility of the parent to provide daily transportation.
- Due to the potential allergic reactions to food or drink, there is absolutely NO eating or drinking on the school bus.

Communication will be sent to students providing their bus number and approximate pickup time. These bus routes are subject to change due to last-minute enrollments. Please call the Transportation Center at 315-668-3771 if your child will be boarding the bus at a sitter's home or if you do not receive a communication from the district.



Please note, the 5:15 bus route does not drop your student off at home. This route is available for high school and middle school students only. For further information regarding these routes, please contact the district Transportation Office. Some of the high school and middle school bus routes will have designated bus stop locations. This plan creates neighborhood-based transportation bus stops aimed at streamlining bus routes for high school and middle school students.

Child Nutrition

We sincerely hope this year will be a rewarding educational experience as we welcome your child to school. One of the most important ways the Board of Education helps to ensure our students achieve success in their classrooms is by providing them with the nutritious foods necessary for proper development of their minds and bodies.

Our school district participates in the National School Breakfast and Lunch program and qualifies under the Community Eligibility Provision (CEP). We must follow all USDA regulations and guidelines. This federally funded program will continue in September 2024 and will provide all students one (1) full breakfast and one (1) full lunch daily at no charge. À la carte items such as milk, snacks and second entrees are not included in this program.

Families must complete a Household Income Eligibility form unless they receive a Direct Certification letter from our office. These forms are available on our website or in this publication and must be completed in order for the district to continue to receive federal funds.

MySchoolBucks

MySchoolBucks makes applying funds to a student account easy, convenient, private and secure. Enrollment is free and allows you to view the last 90 days of meal history and/or make payments. In order to use the optional online prepayment service, a convenience fee is assessed by the processing company to cover bank fees each time funds are applied.

Health Services Department

Our district nurses in the Health Services Department want to ensure the maximum physical, mental and social development of every child in the district. This program is an important part of the district's overall mission.

Each building in the district has a nurse available for first-aid treatment and to handle any emergencies/illnesses that may occur during school hours. Parents will be notified immediately of any such occurrence. Parents are responsible for transporting their children if they need to leave the building.

It is imperative that the school nurse has updated emergency telephone numbers at all times. The nurse is your child's advocate and wants the best situation for your child while attending school. Please communicate with your school nurse so they are able to make accommodations for your child's health needs as necessary.

Please consult our district website, Health Services, for additional information, forms, etc.

Physical Exams and Screenings

New York state law requires a health examination for all students entering the school district for the first time and for students entering grades Pre-K, K, 1, 3, 5, 7, 9 and 11; annually for interscholastic sports; and working papers as needed; or as required by the Committee on Special Education (CSE) or Committee on Preschool Special Education (CPSE). The date of examination must be noted on the form and be not more than 12 months prior to the start of the school year.

As a reminder, all health examinations performed for public school students must be documented on the NYS Required Health Examination Form or the electronic health record (EHR) compatible form. These are the only forms that can be accepted.

The exam must be completed by a New York State licensed physician, physician assistant or nurse practitioner. A copy of the health examination must be provided to the school within 30 days from your child's start date or when your child enters the grades listed above. If a copy is not provided to the school within 30 days, an examination of the student will be made at the school.

If your child has an appointment for an exam during this school year that is after the first 30 days of school, you must notify your school nurse with the date.

Physical exams include calculating the student's body mass index (BMI). This information is sent to the NYS Department of Health, but no names are given. If you do not want your child's BMI information included in the report to the state, please notify your school nurse by December 1.

A dental certificate which states your child has been seen by a dentist or dental hygienist is also asked for at the same time for all newly entering students and students entering grades 1, 3, 5, 7, 9, and 11.

Immunizations

Children attending pre-K through 12th grade in New York State must receive all required doses of vaccines on the recommended schedule (<https://www.health.ny.gov/publications/2370.pdf>) to attend or remain in school unless they have a valid medical exemption to immunization. A medical exemption is allowed when a child has a medical condition that prevents them from receiving a vaccine.

Within 14 days of the first day of school (September 4, 2024) parents must:

- Show proof of their child's up-to-date vaccinations, OR
- Provide a valid medical exemption from vaccination.

To attend or remain in school, children who are unvaccinated or overdue must receive at least the first dose of all required vaccines within the first 14 days. They also must plan to receive all follow-up doses at the ages and intervals (time between doses) listed in the recommended vaccination schedule. <https://www.health.ny.gov/publications/2370.pdf>

Medications

NYS Education Law states NO MEDICATION of any kind is to be given at school without doctor and parent WRITTEN authorization. This includes prescription, herbal, topical and over-the-counter medications. The necessary forms are available on the district's website and from your child's school nurse.

Every Student Succeeds Act (ESSA) requires that parents receive notification regarding access to information and services.

Teacher Certification

As a parent of a student in the Central Square School District, federal law allows you to ask for certain information about your child's teachers. You have a right to request the following information:

- Whether they hold a valid state certification for the subjects they are teaching
- Whether they are teaching under emergency or temporary credentials
- Their baccalaureate degree majors, and any other graduate certificates or degrees they hold
- Requests for this information should be made in writing to the Superintendent of Schools.

Title I

Title I services provide access and support for students who may be lagging behind their peers.

McKinney-Vento Homeless Education Assistance Act if you live in any of the following situations:

- In a shelter, motel, vehicle or campground
- On the street
- In an abandoned building, dwelling, or other inadequate accommodations, or
- Doubled up with friends or relatives because you cannot find or afford housing

Students with Disabilities

Those students identified by the Committee on Special Education (CSE) as students with disabilities are given the support necessary to remain in the least restrictive environment. Contact the Pupil Personnel Services Office should you have questions regarding the CSE process.

Asbestos Management Plan

In accordance with the Asbestos Hazard Emergency Response Act of 1986, all buildings in the Central Square Central School District have been inspected for asbestos containing building materials (ACBM). The original inspection and triennial re-inspection reports identifying the location of ACBM, the management plan detailing how the district is managing the asbestos material within the buildings, and the semi-annual surveillance reports are available in the main office of each building and the Maintenance Department. Pesticide Management Plan

The Central Square Central School District uses integrated pest management practices to reduce the use of pesticides in the school buildings and on the grounds. New York state law requires that schools maintain a list of staff and parents who wish to receive written notice forty-eight (48) hours prior to a pesticide application at their school facility if the building will be occupied within seventy-two (72) hours of application. 

FERPA: Access to Student Records

The Central Square School District Board of Education has designated the following types of student information contained in student educational records as “directory information,” which may be publicly disclosed without parental consent: each student’s name, address, telephone listing, major field of study, grade level, participation in officially recognized activities and sports, height and weight (if member of athletic team), dates of attendance, honors, degrees and awards received, photograph, and most recent educational agency or institution attended. Photo and video images are also considered to be “directory information” by the district. Students may be videotaped and/or photographed while engaged in classroom and extracurricular programs, activities and other school functions.

Video and/or photography may be shared with the public through, for example, public media outlets, the district newsletter, reports, website, other district communications or CiTi BOCES when participating in CiTi sponsored events.

Parents (or students who are 18 or older) have the right under the Family Educational Rights and Privacy Act to refuse to permit any or all of such information to be disclosed without their consent, except as provided by law. Any parents (or student who is 18 or older) who refuse to permit disclosure must notify the School Business Manager at the Business Office in writing, Central Square Central School District, 44 School Drive, Central Square, NY 13036 on or before October 2, 2024 of the types of information that they do not want disclosed.

PPPA : Protection of Pupil Rights Amendment

Periodically, the district will survey students. We will not collect information on any of the protected: political affiliations of students or parents; mental or psychological problems of students or parents; sex behavior or attitudes; illegal, anti-social,

self-incriminating or demanding behavior, critical appraisals of others with whom respondents have close family relationships; legally recognized privileged or analogous relationships such as with lawyers, doctors, or ministers; religious practices, affiliations, or beliefs of the students or parents; income, other than as required by law to determine program eligibility or for receiving financial assistance under such a program.

Parents have the right to review the surveys; and if they choose, opt students out. Any parent who wishes to opt students out of district or school surveys must notify the School Business Manager at the Business Office in writing, Central Square School District, 44 School Drive, Central Square, NY 13036 on or before October 2, 2024.

Military Recruiter Access

The release of student directory information is not to be confused with the release of names, addresses and telephone listings of eligible students (i.e., a student 17 years of age or older or in the 11th grade, or its equivalent, or higher) to military recruiters. The school district will notify parents that by law it routinely releases this information to military recruiters upon request, unless parents or eligible students submit a written request to not disclose this information.

SEL Services

Every school in our district has social emotional support teams that are here to support you!

Every school in our district has a team of staff members who are here to support students' and their family members' social and emotional well-being. Every building has a counselor(s), a school psychologist(s), a social worker or social worker assistant. School Social Workers provide opportunities for social emotional learning throughout the school year. School Social Workers act as a liaison between home, school, and community services/resources. They also provide short-term counseling, attend CSE meetings, as well as offer crisis management and intervention services.

If you are experiencing challenges related to school, stress in or out of school, difficult emotions, or difficult situations at home, you can reach out to any of our team members for help. Staff members on our support teams will connect with you to talk about what is going on and make a plan for how they can help. That may be a plan to check in with you regularly, a plan to help you problem solve what is going on, or a plan to connect you to resources outside of school that might be able to help you. We are here for you!



In addition, Central Square has partnered with the following organizations to support our students and families.

Family and Support Services/Educational Advocacy

ARISE (PVM, CSMS)

Students with identified disabilities can receive support in connecting with community resources.

School Based Mental Health Clinicians

ARISE (AA Cole, MHE, CSMS, PVM)

Our school-based clinicians provide prevention and treatment to children and families who are experiencing emotional distress. Goals may include reducing truancy and behavioral problems by working with partners throughout the child's system of care, including school counselors and health care providers.

Family Services related to Substance Abuse

FARNHAM FAMILY SERVICES (PVM, CSMS)

Students are recommended into this school-based prevention program to help reduce risk factors related to substance abuse and related issues.

Pregnancy Prevention Services/Teen Health Issues

CiTi BOCES APPS (PVM)

This service includes 1:1 or small group health education/counseling, confidential pregnancy testing, transportation (with parent permission), and enhanced information and referrals.

SchoolTool Parent Portal

The Central Square School District uses a Parent Portal called SchoolTool. SchoolTool allows password protected online access of student grades, discipline, assignments and attendance. Help Your Child Succeed in Preschool and Kindergarten Build the Habit of Good Attendance

DID YOU KNOW...

Showing up on time every day is important to your child's success and learning from preschool forward.

Missing 10% of school (1 or 2 days every few weeks) can make it harder to:

- Gain early reading and math skills.
- Build relationships.
- Develop good attendance habits.

High quality preschool and kindergarten has many benefits!

- The routines your child develops will continue throughout school.
- Make the most of early grades by encouraging your child to attend every day.

WHAT YOU CAN DO

- Work with your child and his/her teacher to develop your child's strong attendance.
- Talk about it – sing about it – make it an adventure!
- Set a regular bedtime and morning routine.
- Lay out clothes and pack backpacks the night before.
- Share ideas with other parents for getting to school on time
- If your child seems anxious about preschool or kindergarten, talk to the program director, teacher, your doctor or other parents for advice.
- Develop backup plans for getting to school if something comes up. Call on a family member, a neighbor or another parent.
- Keep your child healthy and make sure your child has the required shots.

Keep Your Child On Track in Middle and High School: Pay Attention to Attendance

DID YOU KNOW...

- Students should miss no more than 9 days of school each year to stay engaged, successful and on track to graduation.
- Frequent absences can be a sign that a student is losing interest in school, struggling with school work, dealing with a bully or facing some other difficulty.

- By 6th grade, absenteeism is one of three signs that a student may drop out of high school.
- By 9th grade, attendance is a better predictor of graduation rates than 8th grade test scores.
- Missing 10%, or 2 days a month, over the course of the school year, can affect a student's academic success.

WHAT YOU CAN DO


Make school attendance a priority

- Talk about the importance of showing up to school every day.
- Help your children maintain daily routines, such as finishing homework and getting a good night's sleep.
- Try not to schedule dental and non-COVID-related medical appointments during the school day.
