- ✓ <u>Cafeterias</u>: We are utilizing approved barriers in the cafeterias and students will obviously remove their masks when they eat. They will be seated at an appropriate distance in the cafeterias, and as mentioned, we purchased more than enough barriers.

## ✓ Limited Service Laboratory (LSL) Update:

The District has applied for a LSL certificate and are waiting to get confirmation that we have been approved so we can provide COVID-19 tests to our students at no charge to their parents/guardians. As you can see from the NYS Guidelines, COVID-19 testing and/or proof of being fully vaccinated is a NYS requirement for some of the options. There is a cost to the District each time a rapid COVID-19 test is administered, so we are limiting the use of the rapid COVID-19 tests for large-scale events. **Please understand, these are not the Central Square Central School District's rules, however, we are required by NYS to follow these mandated protocols.** When we are officially approved, we will notify all parents/guardians.
