Re: Paul V. Moore H.S. Schedule and CiTi Schedule

Dear Students and Families:

As you may already know, student schedules are now available on SchoolTool. Because you are enrolled in a CiTi program (either AM or PM), you will notice on your schedule that one half of your schedule states, “CiTi/BOCES AM” **or** “CiTi/BOCES PM.” This is stated that way on your schedule because it is simply when the program is offered if we would be returning to in-person schooling.

IMPORTANT: Please note that the day you are scheduled to go to the CiTi campus for your programming has not changed. Below you will find two examples that we hope will clarify any questions you may have. After reading the examples and are still unsure with what to do, please reach out to your School Counselor at 315-668-4231.

Example 1: Student 1 is scheduled to be at CiTi campus for programming on Tuesday’s but this is what their schedule states:

So, this student would login to his/her scheduled PVM virtual classrooms on Monday’s, Thursday’s, and Friday’s periods 1 and 2. On Tuesday, this student will be at CiTi in-person and cannot log into their classes. Because the student will be at CiTi, this student and his/her teachers will make arrangements for the student to receive the virtual lessons and/or assignments he/she missed due to being at CiTi. As previously mentioned, students missing virtual classes because

they are assigned to be at CiTi will not be penalized by PVM staff and arrangements will be made to accommodate the student's schedule.

Example 2: Student 2 is scheduled to be at CiTi campus for programming on Wednesday's but this is what their schedule states:

Period 4 Time 1:45 - 2:45	ENGLISH 12	ECONOMICS	ENGLISH 12	ECONOMICS

So, this student would login to his/her scheduled PVM virtual classrooms on Monday's, Tuesday's, Thursday's, and Friday's Periods 3 and 4. On Wednesday's, the student does not have virtual classes at PVM and he/she will be at CiTi in-person.
