Executive Budget Proposal for 2024 – 2025

- 1. State Aid increase of \$507 million or 2.1%.
- 2. Reduces by \$400 million the Foundation Aid level called for by the formula now in law.
- 3. Included full funding of reimbursement aids for schools.
- 4. Inflation factor reduced from 4.1% to 2.4%
- 5. Eliminates Save Harmless

Executive Budget Proposal Items of Interest

- 1. Repeal COVID-19 Sick Leave Law
- 2. Continued P-Tech Funding
- 3. Some funding towards School Meal Programs.
- 4. Does not include Retiree Income Waiver
- 5. Does not include Funding for Prior Year Adjustments

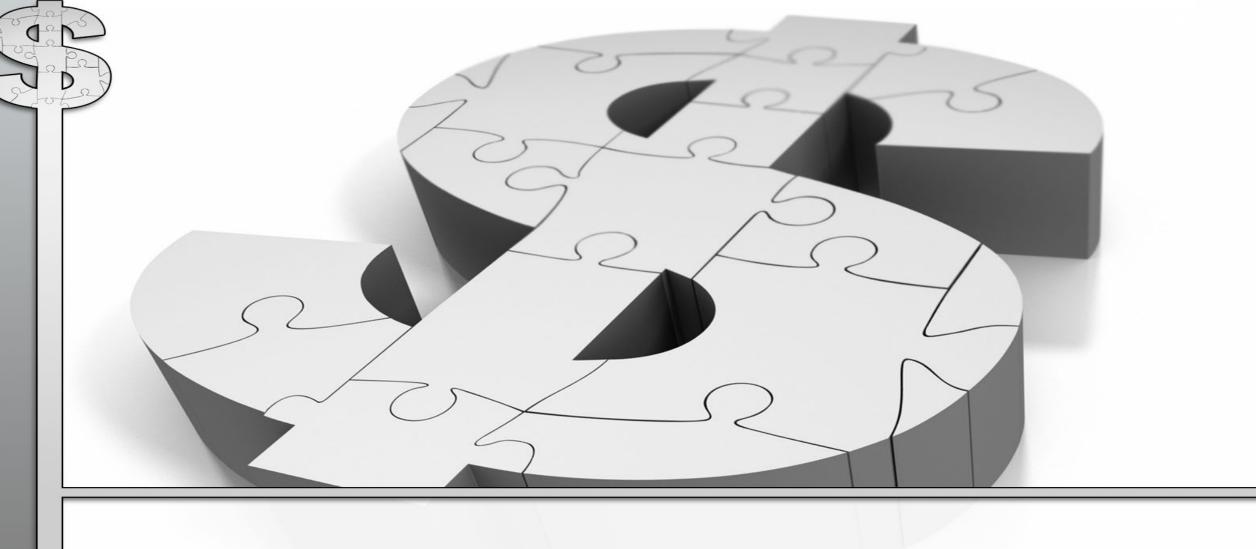
